Meeting called to order at 1:07 pm EDT. Quorum confirmed.

- Motion to approve meeting minutes from previous meeting. Unanimously approved.
- SURF26 Update (Mike, Kristin)
 - o Meeting invite has been sent out for SURF 26 Webinar. July 17 9-11am PDT
 - Imagine H2O Participation Jake has been the point of contact for this partnership.
 Topic of presentation is TBD (will be related to groundwater reuse). COO has volunteered to present.

- Quantifying social aspects of SR (Battelle)
- o Sustainable return on investment (URS Andrea Bohmholdt)
 - Paul Yaroschak (DOD) is another resource on this topic
- Case Studies Amanda sent the two case studies received by the CSI team to date as an option for a presentation. These have not been reviewed by the CSI team yet.
- We should invite the attendees from the forum to attend the webinar. Olivia will take the lead on inviting these attendees. Buddy has the full list of attendees.
- Suggested presentation from environmental economist at Mt Claire State University on the "social costs;" however, this strays from the intended theme of SR implementation.
- o Nick will kick off the webinar with some introductory SURF information.

SURF27 Update

- Pittsburgh Duquesne University is an option; however the date cannot be selected until the Academic Calendar has been finalized at the end of June.
- o Baltimore Karin is evaluating venues that meet our criteria.
- o If an east coast venue does not work out, then Colorado State is an option.
- o University of Michigan is an alternative venue (Ann Arbor). Keith will investigate.
- SURF28 Kristin to coordinate with Buddy regarding a meeting in DC for early 2015.
- SRI National Forum Feedback/Follow Up (Nick, Buddy)
 - o THG will be sending out a meeting summary report.
 - Takeaways: Concept of GSR needs to be simplified; What are the top things you need to consider when evaluating GSR; SR is already being implemented, there should be more focus on attention to it; Cross-departmental collaboration is important
 - Challenges: Umbrella programs at EPA (e.g. UST, RCRA) may be difficult targets; EPA
 Regions have autonomous GR policies/programs
 - Next steps:
 - Incentives (GSR Award forum for GSR SURF as judges);
 - Publicizing case studies
 - More exchanges at conferences and meetings
 - ITRC volunteered to do surveys regarding lack of engagement at state level
 - Identify GSR champions at the state level
 - Mathy Stanislaus agreed that EPA would consider a Memo of Emphasis. Vision across federal programs that supplement GR with societal and economic aspects. Mathy to work with EPA and then circulate to the group for review.
- Administrative Support Job Description (Amanda)
 - Angela has provided a draft "job description" for various administrative support activities.
 - Next steps include estimating the hours required and associated costs and publicizing the need (website, newsletter, etc.).
 - Amanda, Keith and Jake to coordinate offline to move this forward.

Battelle

- Monterey takeaways, etc.
- o 2015 Miami Sponsorship (Rick)
 - GSR will not be a topic at the Monterrey conference in two years. Battelle has asked SURF to sponsor the 2015 conference in Miami (but still substantial). Concern is that the off-year conferences are not as well attended. Cost of sponsorship is \$12,500. Battelle has approached us to be involved in the planning team. Value to SURF from sponsoring the conference is a platform for membership engagement (as session chairs, presenters, planning, etc.)

- In regard to finances, we have the cash available and have less money budgeted for student chapters than in previous years. Expenditure of \$12,500 would have a larger impact at a conference of several hundred attendees (as opposed to a smaller SURF meeting of 25-50 people).
- As a sponsor, we would be able to contribute to the topics of the conference, sessions, and presentations. We may have an opportunity to increase attendance with focus on GSR.
- Motion to sponsor the Battelle Bioremediation and Sustainable Technologies Conference in 2015. Unanimously approved.
- Rick volunteers to be the SURF point of contact for Battelle, including participating with the planning commit and coordinating internally with SURF members (identifying themes, topics, etc.).
- Sponsorship of student paper competition suggested coordinating with student chapter chairs and professors to discuss themes.
