Meeting called to order at 1:05 pm EDT. Quorum confirmed.

- New additions to agenda
- Approve meeting minutes from last Board call. Unanimously Approved.
- SURF27 Update
  - Venue and dinner are finalized. Dinner is at the Jolly Pumpkin on November 11. A flyer has been finalized to target potential participants at the University and those who may not be familiar with SURF or remediation. It has been circulated locally. Brad Bradley (USEPA Region 5) and Sharron (PG&E) are confirmed speakers. A local contractor is interested in presenting on brownfields. Doing outreach with other University Departments for participation. Registration email was sent last week to SURF email distribution.
  - o Travel Request from Jennifer Borski (Kathy). Not yet received.
  - Student from Colorado emailed about support for the meeting. Amanda will review past minutes to determine funding amount allocated and send to Rick.
  - Angela will bring the SURF 2014 Year in Review Document and the Technical Initiative Flyer to the Society for Environmental Toxicology and Chemistry (SETAC) Conference in November.
- SURF28
  - Venue is confirmed for Boeing in Arlington, VA. Dates are February 24-26, 2014. Agenda needs to be built. Nick will contact Mike and Kristin to start the planning.

Abstracts are due September 30, but more time may be allotted if needed. Abstracts are sent to Battelle. After they have been submitted, the co-chairs will receive a link to download and review and decide on platform and poster presentations. Suggested to devote a breakout session to process improvement and development of action items. Keith will talk to the planning team and Bruce about this session. Bruce Wilkinson could lead the session if he is attending.
