Meeting called to order at 1:06 pm EDT. Quorum confirmed.

- New Additions to the Agenda
- Approve meeting minutes from October 23, 2015 Board Meeting. Unanimously Approved.
- Meeting Facilitator Update.
 - November 9; however, she has been tasked with organizing a meeting that conflicts with SURF 31, so she has formally withdrawn her candidacy for the SURF Facilitator position. The Facilitator selection committee has discussed making an offer with a contract inclusive of SURF 31 planning, facilitation, and follow up as a trial period. Continuing services or an extended contract would be evaluated as needed in 2016.

- o If we partner with another organization for a national conference, the facilitator role may change or be reduced. However, since this is still a work in progress, it probably does not impact immediate needs for SURF 31. However, the typical schedule for SURF meetings under a new organizational paradigm is still uncertain. There still be a need for the remainder of 2016, but that will be worked out as we go. Amanda suggested that we move forward with a contract to get Philip working on SURF 31.
- Amanda, Maile, Kristin, and Keith will prepare a draft contract for K&L Gates review and approval by the Board. Amanda, Maile, and Kristin will also develop a written offer letter to provide to Philip.

SURF 31 Meeting Update

- o Kristin is sending out a Doodle poll to organize a meeting for next week. Sonya and Shannon will be sending Kristin a detailed description of the proposed theme as well as suggestions of 3-5 speakers. The speakers will be submitted to Kristin and the committee for review. The Parsons facility is officially booked for the meeting. A local support person will be identified for the SURF dinner. The theme for the meeting is "Climate Change, Resilience, and Remediation".
- Discussion of whether the theme will attract a broad spectrum of remediation professionals. The theme will need to be very well described with specific reference to remediation.
