- Gerlinde: why have the SURF dinner on Thursday? (Paul) SURF business meeting is SURF members only and is on Thursday afternoon and it was the easiest to not compete with other dinners at the conference.
- Dates for planning of the AEHS meeting are coming up quickly. How would we know if the first conference alignment was a success when we start planning the next conference in the summer of 2017, well before we hold our first alignment conference? Draft agenda for 2018 won't need to be finalized until December 2017. This will give SURF a month from the Fall AEHS conference alignment until need to decide if we move forward to San Diego in 2018.
- SURF 34: (Paul) need to send out a call for abstracts. Panel will include partnering with GRA. Groundwater Management Act in California will be presented. We will also discuss the AEHS conference alignment progress. A big thank you to Kristin for all of her efforts.

Committee/Initiative Updates:

- Finance (Keith): What can we do to increase sponsorship?
 - Tetra Tech will continue as a Bronze sponsor
 - Need to consider how to transition with Kathy's role as she is a cost to the organization, and if we are going to start partnering with AEHS, how that will change the way we operate.
 - Sponsorships look at membership list and who we see returning to the conferences. Approach these firms if they would like to become a sponsor.
 - Perhaps we should begin looking at vendors more aggressively.
 - Review the vendors/contractors that we are adding to our product list
 - Look at the vendors at the AEHS conference in Amherst and San Diego.
 - Rick recommend starting a small sub-team/committee.
 - Perhaps we develop different levels of partnerships/sponsorships
 - We need to make sure the benefits are outlined and how it will differ from the sponsorships for Bronze, Silver, Gold
 - Need a more intentional plan
 - Keep this on the agenda for the next meeting
- Technical Initiatives:
 - Climate and Resiliency (Barbara): No update
 - Social Aspect of Sustainable Remediation (Barbara): No update
 - Value of Sustainable Remediation (Gerlinde): The Value of SR TI group is preparing their survey together and wanted to check SURF requirements or recommendations for survey distribution?
 - Do we have guidelines on survey requirements? John indicated there's nothing in the bylaws.
 - The survey will go out to people in and outside of SURF
 - Plan is to use Survey Monkey
 - Goal is to send out in February, results back by the end of February, discuss results at the SURF 34 meeting
