LA Metro Sustainability Council	Roy	5/8/2020 Meeting update	Response to COVID-19
LA Metro Sustainability Council	KUY		Metro management and staff provided an overview of their efforts to adapt to the dynamic changes occurring from COVID-19. Metro has seen a 50% - 70% drop in ridership, with a projected \$800M to \$1BN loss in revenue through June 2020. Metro is looking at options for improving protective measures for drivers and the public. Some actions already taken include, rear bus entry and protective barriers for drivers. On a positive note, Metro construction projects have benefitted from the reduction in traffic. <b>LA County Goods Movement Strategic Plan</b> Metro staff gave an overview of LA County's Goods Movement Strategic Plan. The presentation highlighted the integrated effort between ports, rail and trucking to continue to provide for the safe and reliable delivery of goods. Some interesting facts about LA County goods movement are: The 10th busiest container port complex in the World; the Nations' 6th busiest air cargo hub; generates \$10.9 billion in sales tax from related retail and foods service sectors in LA County; and, \$1.7 trillion worth of goods moved into, out of, and within the Los Angeles Region. Key questions that the Plan is looking to address are: How do we ensure economic and environmental sustainability and viability? Will our transportation system be able to handle demand? What are the equity elements that are most impacted by goods movement activities? How do we finance new infrastructure and technology? What will the needs and workforce of the goods movement/supply chain system look like in the future?
