## **Dive In! Washington State Ecology Publishes Revised Guidelines**

In January 2023, the Toxics Cleanup Program of the Washington State Department of Ecology published *Sustainable Remediation: Climate Change Resiliency and Green Remediation*, a revision of the guide originally issued in November 2017. The revised guide covers environmental trends and climate change projections, how to do a site-specific vulnerability assessment, when to consider climate change impacts, and how to increase the resilience of different remedial alternatives.
