Last month, over 650 people from around the world attended the 8th International Sustainable Remediation Conference (SustRem2023) in Melbourne, Australia, to learn and share sustainable practices for managing contaminated sites. The conference was hosted by the Australasian Land & Groundwater Association (ALGA) and SuRF-Australia/New Zealand (SuRF-ANZ) and held in conjunction with ecoforum. The program included over 120 speakers (!), prompting lively discussions and thoughtful exchanges of ideas. Perhaps attendees were inspired by their surroundings. The conference was held at the Grandstand Building of the 183-year-old Flemington Racecourse, a work of art in and of itself. The building design was inspired by the shape of the race track; the 16,000 Roses of Flemington; and the hats donned by spectators at the annual Melbourne Cup Carnival (click <u>here</u> for photo).



# Dive In! Federal Agencies' Environmental Justice Plans and Progress

Last month, the White House Council on Environmental Quality published

Strategic Planning to Advance Environmental Justice (click here to access). The document provides Federal agencies with a template for environmental justice strategic plans. The plans are required per last year's Executive Order (EO) 14096, *Revitalizing Our Nation's Commitment to Environmental Justice for All.* Per the EO (click here), agencies were required to make their strategic plans available to the public by October 21, 2023 and include a section on their Environmental Justice Scorecard, which was established as part of EO 14008, *Tackling the Climate Crisis at Home and Abroad.* Click here to access agencies' scorecards.
