



President Biden Signs Executive Order on Catalyzing America's Clean Energy Economy through Federal Sustainability

On December 8, 2021, President Biden signed an [Executive Order 14057](#) referred to as the “Federal Sustainability Plan” that establishes goals (see image above) to achieve the overall objective of reducing U.S. greenhouse gas emissions by 50% to 52% from 2005 levels by 2030 and limiting global warming to 1.5°C. The Office of Federal Chief Sustainability Officer (part of the White House Council of Environmental Quality) is leading the charge and issued the Federal Sustainability Plan (available [here](#)), which details the goals. On the same website (click [here](#)), downloadable, interactive graphs show specific government-wide progress, and an interactive map shows examples of some of the actions taken to date.
